WHEREAS, C.R.S. 12-47-505 authorizes the Board of County Commissioners of Ouray County, Colorado as local licensing authority to establish a schedule of fees concerning the granting of liquor licenses within said County; and

WHEREAS, pursuant to such authority, the Board of County Commissioners of Ouray County, Colorado has established the Liquor License Fee schedule attached hereto as Exhibit "A" and incorporated herein by reference; and

WHEREAS, said Board of County commissioners finds that such Liquor License Fee schedule attached hereto is in the best interest of Ouray County, Colorado and the citizens residing therein as such schedule facilitates the application and granting of liquor license with said County;

NOW THEREFORE, be it resolved by the Board of County Commissioners of Ouray County, Colorado, that the Liquor License Fee schedule attached hereto and incorporated herein, is adopted as of the date of the execution of this resolution.

Be it further resolved that such fee schedule may be amended from time to time as appropriate in accordance with the above referenced statutory authority.

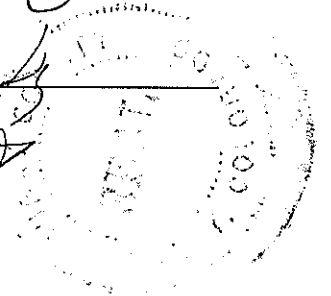
