

**OURAY COUNTY, COLORADO**

**A RESOLUTION LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 2003, TO HELP DEFRAID THE COSTS OF GOVERNMENT FOR TH ECOUNTY OF OURAY, COLORADO, FOR THE 2003 BUDGET YEAR**

**WHEREAS**, the Board of County Commissioners of the County of Ouray, Colorado, have adopted the annual budget in accordance with the Local Government Budget law, on December 16, 2002, and

**WHEREAS**, the amount of money necessary to balance the budget for general operating purposes from property tax revenue is as follows:

County General Fund:	\$ 815,249
Road and Bridge Fund:	\$ 252,430
Social Services Fund:	<u>\$ 55,737</u>
<b>Subtotal</b>	<b>\$1,123,416</b>
Recovery of Taxes Abated:	<u>\$ 1,468</u>
<b>Total Property Tax Revenue:</b>	<b>\$1,124,884</b>

**WHEREAS**, the 2002 valuation for assessment for the County of Ouray, Colorado, as certified by the County Assessor is \$100,972,170.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of the County of Ouray, Colorado:

That for the purpose of meeting all general operating expenses of the County of Ouray, Colorado, during the 2003 budget year there is hereby levied a tax of 11.141 mills upon each dollar of the total valuation for assessment of all taxable property within the County of Ouray for the year 2003 as follows:

County General Fund:	8.074
Road and Bridge Fund:	2.500
Social Services Fund:	<u>.552</u>
<b>Subtotal:</b>	<b>11.126</b>
Recovery of Taxes Abated:	<u>.015</u>
<b>Total Mill Levy:</b>	<b>11.141</b>

**NOW THEREFORE, BE IT FURTHER RESOLVED** by the Board of County Commissioners of the County of Ouray, Colorado that the mill levies hereinabove determined and set are based upon the final (December) certification of valuation from the County Assessor.
