

**OURAY COUNTY, COLORADO**

**A RESOLUTION ADOPTING THE EXPENDITURES AND REVENUES  
FOR EACH FUND, AND ADOPTING A BUDGET FOR  
THE COUNTY OF OURAY FOR THE CALENDAR YEAR  
BEGINNING ON THE FIRST DAY OF JANUARY, 2006  
AND ENDING THE LAST DAY OF DECEMBER 2006**

**WHEREAS**, a budget has been submitted to the Board of County Commissioners of Ouray County, Colorado; and

**WHEREAS**, upon due and proper notice published in accordance with the laws of Colorado, said budget was open for inspection by the public at the County Administrator's office, a public hearing was held on Monday, December 12, 2005 and interested taxpayers were given the opportunity to file or register any objections to said budget; and

**WHEREAS**, whatever changes may have been made in the expenditures, like changes were made to the revenues so that the budget remains in balance as required by law.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of the County of Ouray, Colorado:
