

**A RESOLUTION OF THE  
BOARD OF COUNTY COMMISSIONERS OF OURAY COUNTY, COLORADO  
APPOINTING MEMBERS FOR THE BOARD OF APPEALS  
PURSUANT TO THE 1997 EDITION OF THE UNIFORM BUILDING CODE  
FOR THE ABATEMENT OF DANGEROUS BUILDINGS**

**WHEREAS**, by Resolution 2000-062 the Board of County Commissioners of Ouray County ("Board") adopted the 1997 edition of the Uniform Building Code, including the Uniform Code for the Abatement of Dangerous Buildings ("Abatement Code"); and

**WHEREAS**, pursuant to the provisions of the Abatement Code, the Ouray County Building Official ("Building Official") is authorized to issue orders, decisions and determinations concerning the abatement of dangerous buildings; and

**WHEREAS**, the Abatement Code provides that appeals of orders, decisions and determinations made by the Building Official shall be heard by a Board of Appeals; and

**WHEREAS**, the Board of Appeals shall be comprised of members who are qualified by experience and training to pass upon matters pertaining to building construction and who are not employees of the jurisdiction; such members of the Board of Appeals to be appointed by the Board and to hold office at the pleasure of the Board; and

**WHEREAS**, the Board has determined that the members of the Town of Ridgway Board of Appeals possess the necessary qualifications to serve as the Board of Appeals for Ouray County under the provisions of the Abatement Code;

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF OURAY COUNTY, COLORADO, AS FOLLOWS:**

1. The members of the Town of Ridgway Board of Appeals, namely, Doug Macfarlane, Larry Coulter, Brad McMillon and Brian Peters, are appointed to serve as the Board of Appeals for Ouray County.
2. Such members shall serve for a period of one year or until their successors have been appointed and qualified.
