

**A RESOLUTION OF THE  
BOARD OF COUNTY COMMISSIONERS OF OURAY COUNTY, COLORADO  
AUTHORIZING THE PROCEDURE FOR ROAD AND BRIDGE CLOTHING ALLOWANCE  
PURCHASES FOR 2008**

**WHEREAS**, the Board of County Commissioners of Ouray County, Colorado ("Board") is empowered under C.R.S. §30-11-107(2)(a) to "to adopt the annual budget for the operation of the county government, including all offices, departments, boards, commissions, other spending agencies of the county government, and other agencies which are funded in whole or in part by county appropriations;" and

**WHEREAS**, the Board is empowered under C.R.S. §30-11-107(e) to provide for the management of the business and concerns of the County; and

**WHEREAS**, the Board adopted a 2008 budget and in its adoption approved money for uniforms and clothing for the Road and Bridge Department employees in the amount of \$600.00 per employee in the total amount of \$6,600.00; and

**WHEREAS**, Road and Bridge employees, as defined for the purposes of this resolution are fulltime Road Superintendent, Assistant Road Superintendent, Mechanics, and Equipment Operators; and

**WHEREAS**, the Road and Bridge Superintendent has established an account at Murdoch's in Montrose whereby employees may purchase specific work-related clothing such as safety-toe boots, work pants, gloves, winter work clothing, etc; and

**WHEREAS**, based upon the budgeted amount for uniforms and clothing, the Road and Bridge Superintendent authorized his employees to begin purchasing clothing at Murdoch's and has expended \$1,427.41 thus far; and

**WHEREAS**, the Road and Bridge Superintendent is requesting that the Board adopt this resolution confirming the clothing allowance purchases for the calendar year 2008 only, in an amount not to exceed \$600 per employee, and continuing to utilize the account arranged for such purchases at Murdoch's; and

**WHEREAS**, a formal policy and procedure for a Road and Bridge Clothing Allowance will be developed and delivered to the Board at a future Board meeting for their consideration and adoption to commence budget year 2009.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF OURAY COUNTY, COLORADO, AS FOLLOWS:**

1. Authorizing the Road and Bridge employees, as defined above, to continue their clothing allowance purchases for 2008 only at Murdoch's in an amount not to exceed \$600 per employee.
2. To develop a formal policy and procedure for Board consideration and adoption for all future Road and Bridge clothing allowance purchases commencing budget year 2009.
