RESOLUTION
OURAY COUNTY BOARD OF COUNTY COMMISSIONERS

**Re: Authorization for Ouray County Assessor to
Review and Settle Petitions for Abatement or Refund
In an Amount of \$2,500 or Less**

WHEREAS, pursuant to C.R.S. § 39-1-113 (1.5) "Abatement and Refund of Taxes" the Board of County Commissioners may authorize the Assessor to "review petitions for abatement or refund and settle by written mutual agreement any such petition for abatement or refund in an amount of ten thousand dollars or less per tract, parcel, or lot of land or per schedule of personal property;" and

WHEREAS, the Board of County Commissioners recognizes that increased efficiencies may be derived by authorizing the County Assessor to review and settle petitions for abatement or refund and have discussed with the County Assessor that the Board would be comfortable amending the one thousand dollar (\$1,000) amount previously approved in Resolution 2007-015 and authorizing an amount of two thousand five hundred dollars (\$2,500) or less per tract, parcel, or lot of land or per schedule of personal property; and


WHEREAS, periodic reports from the Assessor listing the petitions for abatement or refund that have been reviewed and settled by the Assessor in an amount of two thousand five hundred dollars \$2,500 or less per tract, parcel, or lot of land or per schedule of personal property shall be presented to the Board of County Commissioners at a regularly scheduled Board of County Commissioners meeting.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Ouray County, Colorado, authorizing the Ouray County Assessor to "review petitions for abatement or refund and settle by written mutual agreement any such petition for abatement or refund in an amount of two thousand five hundred dollars (\$2,500) or less per tract, parcel, or lot of land or per schedule of personal property." "This shall be done within six months of the date of filing such Petition, as per C.R.S. § 39-1-113 (1.7)."


BE IT FURTHER RESOLVED by the Board of County Commissioners of Ouray County, Colorado that periodic reports from the Assessor listing the petitions for abatement or refund that have been reviewed and settled by the Assessor in an amount of two thousand five hundred dollars (\$2,500) or less per tract, parcel, or lot of land or per schedule of personal property shall be presented to the Board of County Commissioners at a regularly scheduled Board of County Commissioners meeting.
