

**A RESOLUTION OF THE
BOARD OF COUNTY COMMISSIONERS OF OURAY COUNTY, COLORADO –
REVISING THE ADOPTED FEE SCHEDULE FOR MARIJUANA-RELATED BUSINESS
APPLICATIONS**

WHEREAS, pursuant to C.R.S. §30-11-107(1)(e), 30-28-114 and 30-28-205, the Board of County Commissioners of Ouray County, Colorado ("Board") is authorized to manage the business and budget of Ouray County, and to establish fees that cover the direct and indirect costs of processing permit applications; and

WHEREAS, Article XVIII, Section 16, of the Colorado Constitution, the Colorado Retail Marijuana Code, C.R.S. 12-43.4-101, *et seq.* and the Colorado Medical Marijuana Code, C.R.S. 12-43.3-101 *et seq.*, authorizes the licensing and regulation of medical and retail marijuana business and affords local government the option to determine whether or not to allow medical and retail marijuana businesses within their respective jurisdictions and to adopt licensing requirements and fees associated with such business applications; and

WHEREAS, the Board recently adopted Ordinance No. 2017-01, permitting cultivation facilities, marijuana product manufacturing facilities, medical marijuana facilities, retail marijuana stores, and marijuana testing facilities; and

WHEREAS, in order to process applications for the marijuana-related businesses approved by the County, the Board established a fee schedule for marijuana-related business applications; and

WHEREAS, an update to the fee schedule for marijuana permits is necessary in order to assess appropriate fees for a "minor modification of premises" versus a "major modification of premises".

NOW THEREFORE, BE IT RESOLVED that the Board of County Commissioners approves the revised "*Fee Schedule for Marijuana-Related Business Applications*" attached hereto as Exhibit A. This schedule of fees shall be effective for all marijuana-related business applications filed after the date of adoption of the fee schedule and until amended or repealed by the Board.
