1. The undersigned is a public procurement unit, as defined in C.R.S. § 24-101-301, that wishes to participate in that certain State Of Colorado Governor's Office Of Information Technology Contract (CMS Routing #174033; Content ID 3037366, referenced in OMR323911) (the "Underlying Agreement") with Qwest Corporation d/b/a CenturyLink QC (CenturyLink QC) approved and signed by the **State of Colorado** (the "State"), acting by and through the Governor's Office of Information Technology ("OIT" or "Customer"), on or about February 25, 2022, including its Exhibits and Attachments, pursuant to C.R.S. § 24-101-301 and other applicable provisions of the Colorado Procurement Code. Such public procurement unit (also referred to herein as "Agency") requests telecommunication services ("Service(s)") pursuant to the terms and conditions of the Underlying Agreement.

2. The undersigned Agency is executing this Participating Addendum for the purpose of purchasing Service from Lumen pursuant to the Underlying Agreement. Agency represents and warrants that it is eligible to purchase such Service pursuant to the Underlying Agreement under applicable law. Agency will be subject to all terms and conditions of this Participating Addendum and the Underlying Agreement. Agency will be responsible for any and all use of Services under this Participating Addendum and the Underlying Agreement, including but not limited to responsibility for payment obligations. Agency will be Lumen's customer of record for the Services provided to Agency under this Participating Addendum and the Underlying Agreement.

3. **DESCRIPTION OF SERVICES.** Lumen will provide to Agency the Services as set forth in the Underlying Agreement. To the extent Services are tariffed, and where such terms and conditions of the applicable tariffs do not conflict with the Underlying Agreement, the provisions of the tariff will apply and, in such cases, references in this Addendum and the Underlying Agreement to Service Schedule(s) will instead be deemed to refer to the applicable tariff.

4. **TERM.** This Participating Addendum is effective on the latest signature date and will expire coterminous with the Underlying Agreement as provided in Section 2 of the Underlying Agreement.

5. This Participating Addendum and the Underlying Agreement set forth the entire agreement between the parties and supersede all previous communications, representations or agreements, whether oral or written, with respect to the subject matter hereof.
